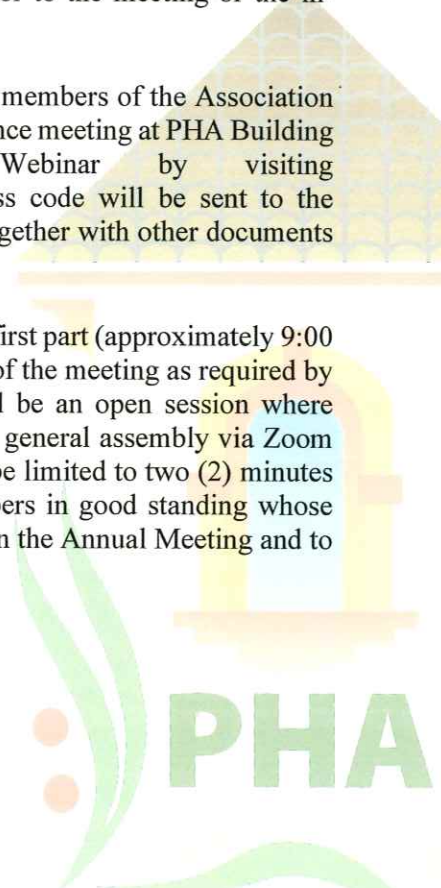
**Subject:** Notice of Annual Meeting of Members

Notice is hereby given that the Annual Meeting of Members of the Palmas del Mar Homeowners Association (PHA) will be held on Saturday, April 23, 2022, at the PHA Building, Palmas del Mar, Humacao, Puerto Rico, with transmission via Zoom Webinar for remote access connectivity. The PHA Board of Directors and Delegates will participate in person at the conference rooms at the PHA building beginning at 8:00 am, along with attendance from PHA Members. PHA will strictly adhere to the safety protocol measures required to protect the health and safety of in-person participants, following the Commonwealth of Puerto Rico most recent COVID-19 Executive Order (OE-2022-019).

Participant registration starts at 8:00 AM and business session scheduled at 9:00 AM. In accordance with the PHA By-laws, as amended, quorum for the Annual Meeting of Members will be established by the attendance of the designated Delegates representing their individual regimes or neighborhoods. Registration of Delegates for the purpose of quorum will take place through pre-registration via telephone call or an electronic message to PHA the day prior to the meeting or the in-presence registration the day of the meeting.

The registration and participation of the general membership, meaning those members of the Association that are not regime designated Delegates, and do not intent to arrive to in presence meeting at PHA Building conference room, can still participate via Zoom Webinar by visiting <https://www.palmaspha.org/annualmeeting/>. The participation ID and access code will be sent to the Delegates and the Membership via separate email. Also, they can be found together with other documents related to the Annual Meeting at [www.palmaspha.com/annualmeeting/](http://www.palmaspha.com/annualmeeting/).

As in past years, the Annual Meeting will be divided in two parts. During the first part (approximately 9:00 am- 10:30 am) the Board and the Delegates will conduct the formal business of the meeting as required by the By-laws. The second part (approximately 10:45 AM - 11:45 PM) will be an open session where participating members may bring other business before the Board and to the general assembly via Zoom Webinar. As established by the General Assembly, member comments will be limited to two (2) minutes absolute maximum to allow greatest membership participation. Only members in good standing whose PHA assessment accounts are current or up to date are entitled to participate in the Annual Meeting and to address the general assembly during the open session.
